No. PA/Khyber Pakhtunkhwa/Bills-163/2021/4491.— The Khyber Pakhtunkhwa Shops and Establishments (Amendment) Bill, 2021 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 23rd August, 2021 and assented to by the Governor of the Khyber Pakhtunkhwa on 09th September, 2021 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

ACT**

to amend the Khyber Pakhtunkhwa Shops and
Establishments Act, 2015

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Shops and Establishments Act, 2015 (Khyber Pakhtunkhwa Act No. XX of 2015), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement. --- (1) This Act may be called the Khyber Pakhtunkhwa Shops and Establishments (Amendment) Act, 2021.

(2) It shall come into force at once.

2. **Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XX of 2015.**--- In the Khyber Pakhtunkhwa Shops and Establishments Act, 2015 (Khyber Pakhtunkhwa Act No. XX of 2015), hereinafter referred to as the said Act, in section 2, after clause (h), the following new clause shall be inserted, namely:

“(h-i) “Department” means the Labour Department of Government;”.

3. **Amendment of section 7 of the Khyber Pakhtunkhwa Act No. XX of 2015.**--- In the said Act, in section 7,-

- (a) in sub-section (4), the words “women or” shall be deleted; and
- (b) after sub-section (4), as so amended, the following new sub-section shall be added, namely:

“(5) A woman employee, with her prior consent, is allowed to work in an establishment beyond 7:00 p.m, subject to mandatory arrangement of transportation facility of pick and drop by the employer at the doorstep or nearest possible place to her residence, except where a separate hostel facility is provided by the employer at such establishment.”.

4. **Amendment of section of 26 of the Khyber Pakhtunkhwa Act No. XX of 2015.**--- In the said Act, in section 26, in sub-section (1), for the word “Government”, the word “Department” shall be substituted.

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**—(1) This Act may be called the Khyber Pakhtunkhwa Factories (Amendment) Act, 2021.

(2) It shall come into force at once.

2. Deletion of section 5 of the Khyber Pakhtunkhwa Act No. XVI of 2013.--- In the Khyber Pakhtunkhwa Factories Act, 2013 (Khyber Pakhtunkhwa Act No. XVI of 2013), section 5 shall be deleted.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Shops and Establishments Act, 2015 (Khyber Pakhtunkhwa Act No. XX of 2015), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement. ---(1) This Act may be called the Khyber Pakhtunkhwa Shops and Establishments (Amendment) Act, 2021.

(2) It shall come into force at once.

2. Amendment of section 25 of the Khyber Pakhtunkhwa Act No. XX of 2015.---In the Khyber Pakhtunkhwa Shops and Establishments Act, 2015 (Khyber Pakhtunkhwa Act No. XX of 2015), hereinafter referred to as the said Act, in section 25,-

(a) in the marginal heading, the words, "and fee for registration" shall be deleted;

(b) for sub-section (2), the following shall be substituted, namely:

"(2) An application for registration of establishment shall be made by the employer in accordance with form A.";

(c) after sub-section (2), as so amended, the following new sub-section shall be inserted, namely:

"(2A) No fee shall be levied for the registration of an establishment under this Act.";

(d) in sub-section (3), the words, brackets and figure, "and the fees specified in sub-section (2)" shall be deleted; and

(e) in sub-section (4), the words, "and shall be renewed annually on depositing fee as may be prescribed" shall be deleted.

3. Amendment of SCHEDULE to the Khyber Pakhtunkhwa Act No. XX of 2015.---In the said Act, in the SCHEDULE, in FORM "A", the Note appearing at the end shall be deleted.
